

TERMS AND CONDITIONS

1. TICKET OR PASS.

1.1. There are 9 different passes for SUPERHEROES 2011:

I) INFINITY PASS: it gives you right to access the conventions zone and all the activities for the whole duration of the convention. It gives you right to attend to a cocktail with the guest actors.

It gives right to get a ticket you can exchange for an autograph of each guest actor. It gives right to get a ticket you can exchange for a photography with each guest actor. It gives right to a reserved chair in the first row on the main hall, and first positions in autographs and photo op queues. It gives right to a *gift pack* with several items to be determined by the organization. It gives right to an exclusive gift that can only be obtained with this type of pass.

II) GOLD PASS: it gives you right to access the conventions zone and all the activities for the whole duration of the convention. It DOESN'T give you right to attend to a cocktail with the guest actors.

It gives right to get a ticket you can exchange for an autograph of each guest actor. It gives right to get a ticket you can exchange for a photography with each guest actor. It gives right to a reserved chair from the 3er row on the main hall, and positions in autographs and photo op queues just after the Infinity Pass. It gives right to a *gift* to be determined by the organization.

III) SILVER PASS: it gives you right to access the conventions zone and all the activities for the whole duration of the convention. It DOESN'T give you right to attend to a cocktail with the guest actors.

It gives right to get a ticket you can exchange for an autograph of each guest actor. It gives right to a reserved chair on the main hall after the Gold Pass, and positions in autographs and photo op queues just after the Gold Pass. It gives right to a *gift* to be determined by the organization.

IV) WEEKEND PASS: it gives you right to access the conventions zone and all the activities for the whole duration of the convention. It DOESN'T give you right to attend to a cocktail with the guest actors.

It gives right to a reserved chair on the main hall after the Silver Pass, and positions in autographs and photo op queues just after the Silver Pass. It gives right to a *gift* to be determined by the organization.

V) ECONOMIC PASS: it gives you right to access the conventions zone and all the activities for 2 days. (Any two days: **Friday and Saturday** or **Saturday and Sunday** or **Friday and Sunday**).

It doesn't give you right to attend to a cocktail with the guest actors. It doesn't give right to a reserved chair. It doesn't give right to a reserved position in queues.

VI) DAY PASS: it gives you right to access the conventions zone and all the activities for 1 day. (Any day: **Friday** or **Saturday** or **Sunday**, just 1 day).

It doesn't give you right to attend to a cocktail with the guest actors. It doesn't give right to a reserved chair. It doesn't give right to a reserved position in queues.

VII) WEEKEND KID PASS: can only be possessed by a person with 14 years old or less (see section 5). It gives you right to access the conventions zone and all the activities for the whole duration of the convention. It DOESN'T give you right to attend to a cocktail with the guest actors.

It gives right to a reserved chair on the main hall after the Silver Pass, and positions in autographs and photo op queues just after the Silver Pass. It gives right to a *gift* to be determined by the organization.

VIII) ECONOMIC KID PASS: can only be possessed by a person with 14 years old or less (see section 5). It gives you right to access the conventions zone and all the activities for 2 days. (Any two days: **Friday and Saturday** or **Saturday and Sunday** or **Friday and Sunday**).

It doesn't give you right to attend to a cocktail with the guest actors. It doesn't give right to a reserved chair. It doesn't give right to a reserved position in queues.

IX) DAY KID PASS: can only be possessed by a person with 14 years old or less (see section 5). It gives you right to access the conventions zone and all the activities for 1 day. (Any day: **Friday** or **Saturday** or **Sunday**, just 1 day).

It doesn't give you right to attend to a cocktail with the guest actors. It doesn't give right to a reserved chair. It doesn't give right to a reserved position in queues.

No obstante, la Organización se reserva el derecho a poner a la venta nuevos tipos de entradas no contempladas en este punto.

1.2 Once acquired, any ticket will be only refund in a month (30 days), a period known as “cooling time” and a legal deadline that the Organization had been set. Holders have to serve the Organization within referred time.

Once upon the legal deadline, all purchases will be final, except in the case of cancellation or date changes, according to the Spanish Law (LEPARA 13/99 ACT) and the applicable law.

1.3 Admission, without affecting what is reflected in these conditions with regard to the right of admission, is contingent on having a complete ticket in appropriate conditions. Tickets are equipped with different security measures to ensure their authenticity. The Organisation will not be held responsible for tickets that were not purchased at official points of sale. Any damaged ticket, or any ticket with signs of being counterfeit, will authorise the Organisation to deny access to the said ticket holder to the event. The Organisation reserves the right to take any and all legal measures it deems opportune against holders of counterfeit tickets.

1.4 In case of cancellation by any talent, the holder will not be refund. The Organisation reserves the right to change, modify or suspend the programme at any time

1.5 Possession of a ticket does not grant its holder or third parties the right to use the ticket or its contents for purposes related to advertising, marketing or promotions

(including, expressly but not exclusively, contests, gifts and/or raffles) associated with the ticket holder or third parties. Failure to comply with this point will obligate the unauthorised advertiser and/or user to pay a penalty equivalent to a thousand times the price of the most expensive ticket to the event, without affecting further claims for general damages. Furthermore, said ticket will be declared null and void immediately.

1.6. Tickets may only be purchased at points of sale expressly authorised by the Organisation, at the box office in the event or in the authorized web sites.

1.7. In the event a ticket is acquired through the website WWW.SHOP.INFINITYCONVENTIONS.COM, holder must provide the name sending an e-mail to the Organization at acreditacion@infinityconventions.com or accreditation@infinityconventions.com; who will send back a receipt and a proof of payment. This voucher must be printed and show at request of the Organization.

In case of acquisition of multiple tickets, holder must provide the name and surname of the rest of the holders of said tickets.

In this case, the person who acquires more than one entry, undertakes to act in good faith with regard to processing of data by third parties and on it's responsible to obtain the express consent of such third parties to treat their personal data, exonerating the organization of any responsibility in that event and pledging at all times to act in good faith and as expeditiously as possible in case of disagreements that may exist with any third party that certifies them. As a security measure, the Organization will require documentary proof of identity recognized by law at the time of collecting their credentials.

1.8 The Organisation warns that it has high-tech procedures in place capable of detecting any kind of photocopied or counterfeited ticket. The Organisation reserves the right to deny access to the holder of a ticket if any anomalies are detected. The detection of any fraudulent use of at-home printing tools will be persecuted in accordance with any and all legislation currently in force, including criminal liabilities.

2. ACCESS THROUGH AUTHORIZED POINTS

2.1. Convention must be accessed only through points authorized by the Organization. In case of access through an unauthorized point or an infraction of this rule, the offender will be expelled by security staff.

2.2 Accreditation card must be kept during the whole event and it must be shown in any case the Organization staff ask for it. Exit from event is allowed but for re-enter is necessary to show the accreditation card.

3. SPECIAL CONDITIONS FOR PASSES WITH GIFTS.

3.1. When you get your accreditation card for your kind of pass you will get gift or gifts included in that kind of pass.

4. SUSPENSION OR CANCELLATION OF THE EVENT

4.1. The Organisation reserves the right to change, modify or suspend the programme at any time.

4.2. In the event of a total cancellation, the Organization will take all reasonable measures to accommodate ticket holders with new dates for the event.

4.3. In case of any ticket refund from the Organization, the distribution cost that sales channels apply to the price of the ticket will not be refunded by the Organization given that the Organization is not the recipient of this charge and this service is understood to be rendered at the time of purchasing the ticket.

4.4. The cancellation, total or partial, of the event due to forces beyond the Organisation's control will not lead to ticket refunds.

4.5. The parcial cancellation of SUPERHEROES or any programmed activities will not give any rights to ticket holder.

Any cancellation or suspension of the event will be according to the Spanish law (LEPARA 13/99 ACT) and the applicable law.

5. RIGHT OF ADMISSION

6.1. The Organisation reserves the right of admission.

6.2. The Organization, making use of its right of admission, and to such effect, establishes the following requisites for the admittance of minors under the age of 18 to the event:

i) Minors under 14 at the date of even (May 20th) may enter the venue accompanied by a legal guardian, providing documentation at the entrance proving legal guardianship with one of the following: Family Book, D.N.I. (National ID Card)/Passport of both the minor and the guardian, authorisation of legal guardianship by the Civil Guard / National Police along with the D.N.I. of both the minor and the guardian. In the case of foreigners, the corresponding and equivalent documentation from their country of origin will be required. Guardian must hold any kind of ticket available.

The legal guardian, either parents or the person in charge of the guard of the minor shall subscribe a document assuming all responsibility, direct or indirect, regarding the access of the minor to the event. In case, anyone of the aforementioned persons refuses to sign this document, the organization will be able to deny the access from the minor to the venue. Document will be available in www.superheroes.infinityconventions.com

Failing to comply with the previous requirements will not give any right to refund the price paid for the entrance of the minor.

ii) According to the applicable law (*artículo 6.a) del Reglamento de Admisión en Espectáculos y Actividades Recreativas de Andalucía, decreto 10/2003 de 28 de Enero de 2003*), the Organization has the right to set diferente age fares:

- Children under 5 accompanied by their parents may enter the venue free of charge. The previous clause about the subscription of the document shall be also applied to them and the parent/guardian must hold a ticket available.

- Children under 14 are offered a 25% off to ECONOMIC, DAY AND WEEKEND tickets, same privileges, with no discount offered in the rest tickets.

iii) The Organization may require a copy of said documentation for its files on the admittance of minors.

In additions to the previously stated, the parent or legal guardian of the minor will be required to sign a document assuming all responsibility, direct or indirect, for the entrance of the minor to the event. In the event that a parent or legal guardian refuses to sign this document, the Organization reserves the right to deny entry of the minor to the concert venue.

5.3. Upon entering the venue, attendees may be searched in accordance with standing legislation; attendees are not allowed to enter the venue with objects that might be considered dangerous by the Organisation, or that are prohibited by law, and this includes professional cameras, video cameras and recorders of any kind.

5.4. The Organization may deny entrance, or expulse from the venue, any ticket holder who does not comply with the instructions of Organisation personnel, or who might reasonably be presumed to be heading for a high-risk or dangerous situation for the ticket holder himself and/or other attendees.

5.5. The ticket holder may be expelled for causing disturbances, carrying drugs or for being in a state of apparent or potential intoxication, each ticket holder personally taking responsibility for any actions that might cause injury to third parties or damage to property.

5.6. In the case of expulsion or denial of entry, the ticket holder will not have the right to any kind of refund.

6. DISABLED ATTENDEES

The event, and the venue and his building, have been purposely designed and built to allow unrestricted access to disabled visitors and to conform to the applicable Spanish law involving disabled visitors.

The Organization aims to provide full access to all the facilities within the venue and recognises that disabled visitors may require extra equipment, facilities and assistance both routinely and in an emergency.

7. INTELLECTUAL PROPERTIES AND IMAGE RIGHTS

7.1. All intellectual property and image rights derived, directly or indirectly, from the artistic performances and/or activities taking place as part of the event are reserved. As such, the capturing, filming or recording of images or sounds without prior written authorisation from the Organization is strictly forbidden.

7.2. Attendees consent to appearing in images taken by authorised media channels for future promotional and/or commercial distribution by the Organization.

8. CAPTURE OF PHOTOGRAPHS OR RECORDING IN ANY FORMAT INSIDE THE PRECINT.

The recording of images or capturing them in any medium, analog or digital will be permitted on the premises, if and when appropriate to comply with the law, morality and generally accepted principles of morality or public order in relation to transmission, distribution, storage, availability, reception or access to them and especially with regard to third parties that may appear in images, in all matters relating to the rights to honor, personal and family privacy and image of those third parties. The acquisition is ruled by the following specific conditions:

- i) **PANEL:** It will be allowed to capture images with flash during the first five minutes of it, expressly prohibited after this lapse of time any use of flash, but not without their use. The recording of images is strictly prohibited.
- ii) **AUTOGRAPHS ROOM:** It is permitted to capture photos while waiting for access to the room, without flash, and image acquisition.
- iii) **HALL OF PHOTOGRAPHY:** Inside the room photography is strictly forbidden to record or capture images, with the exception of those taken or filmed by the photographer expressly authorized for that purpose by the Organization.

These conditions may be modified during the event at the request of the artists involved, which have the final say on this subject by contractual relationship. The Organization assumes no responsibility.

9. PERSONAL DATA

Privacy

According to the Spanish legislation on data protection, specifically the Organic Law 15/1999 of Protection of Personal Data and the Royal Decree 1720/2007 on the regulation of protection of personal data, INFINITY CONVENTIONS SL reports that the personal data provided will form part of a file registered in the Spanish Agency for Data Protection. The file will be responsible for INFINITY CONVENTIONS SL, entity domiciled in the street Martínez De Irala, N ° 2, 2 ° C, 41000 Sevilla.

The purpose of data processing is to properly manage the purchase of tickets for shows, events and / activities under the contract by the customer, and to provide information on these shows to all potential customers interested in them. With respect to data stored in the file, the user should have access to them, to correct, to oppose the treatment of the same and cancel in accordance with the terms established by Spanish law. To do this, you should write to the address above stating the right individual who wants to exercise by providing reliable supporting evidence and recognized in law.

Hereby, the user expressly consents to INFINITY CONVENTIONS SL the use of his data in order to manage the transaction entries and publicity notices about events in which the user may be interested. Moreover, by this document, the user expressly consents and agrees that INFINITY CONVENTIONS SL. share their data with companies associated with the show, event or specific activity, only if it is strictly necessary and whenever they need to provide the user with information regarding the act or event. The user agrees and accepts that such companies associated with entertainment events can access to their data to communicate with him in relation to everything stated above.

Use of personal data

INFINITY CONVENTIONS SL. may use personal information provided by the user to contact him by mail, by phone or email when necessary in connection with transactions entered by the user on the Web or equivalent management. If the user provides INFINITY CONVENTIONS SL his e-mail address expressly agree to receive commercial communications.

Cancel

The holder can unsubscribe on any time by regular mail of INFINITY CONVENTIONS SL., even if he had previously indicated his consent to such contact, connecting to the web www.infinityconventions.es and contacting the contact email or by sending your request to INFINITY CONVENTIONS SL., Martínez De Irala Street No. 2, 2 ° C, 41000, Sevilla.

Children under 14

If the client and / or user is under 14 year old, his guardian or legal representative is the only person who can authorize the processing of personal data of the minor, the organization reserves the right to request if necessary, any document evidencing recognized in law to prove the above representation, all with the to manage properly the appropriate management, while ensuring confidentiality and protection of children against immoral practices and / or inadequate.

Using financial data

The financial data collected are used to authorize and bill payment products and services. When purchasing the holder gives his consent to their personal or financial information be provided to such third parties as necessary to process transactions that the holder makes with us, like credit card companies, banks and shipping companies that operate in our name . This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction. Except as noted above, we will not share financial data with third parties without the consent of the user.

10. LEGAL RESERVE

The Organization will exercise its right to take legal measures, both civil and criminal, as it deems appropriate against the perpetrators of any attempts of fraud, breaking and entering, and/or damages caused to the Organization, directly or indirectly.

11. ADMISSION

In accordance with articles 7 and 8 of Law 10/2003, regarding Shows and Public Establishments and Recreational Activities in the Regional Government of Andalusia, INFINITY CONVENTIONS SL. (the Organization), with company tax code B-91892240 and registered domicile at Martínez de Irala, Nº 2 piso 2º C, Sevilla 4100, as the organiser of the first edition of the SUPERHEROES 2011 establishes the following:

CONDITIONS OF ADMISSION

1. With regard to anything not specifically regulated in these conditions of admission, the terms established in the General Conditions of Tickets Sales for the event as well as regional and state legislation will be applied. These conditions are applicable to both the venue and the event, regardless of the fact that the Organisation has established another set of conditions for the use of its activities in the event as well.

2.- The Organisation can deny access to, or expel from the event any person who does not follow the instructions of the Organisation's personnel.

3.- Disorderly conduct, the possession of illegal drugs, or an apparent or potential state of intoxication are just causes for the denial of entry to, or the expulsion from the event. Anyone who is expelled will be responsible, in all cases, for his or her actions and omissions causing injury to third parties or damage to property.

4.- Expulsion from for any of the reasons outlined in these conditions of admission will not give the expelled party the right to a refund for the price paid for ticket.

5.- Minors aged 16 and 17 may enter the FIB 2011 venue in accordance with the stipulations of article 3 of Law 10/2003, the consumption of alcohol and tobacco being prohibited in all cases.

The Organization reserves the right to establish controls and verification measures for the strict compliance of the previously mentioned prohibitions. As such, the Organisation will expel any minor caught drinking alcohol or smoking from the event.

6.- Minors under the age of 16 may enter the event accompanied by their parents or legal guardians. In order for the Organization to grant entrance to minors under the age of 16, some of the following documents must be presented, depending on the case: the minor's libro de familia, the National ID Cards or passports of the minor and the accompanying adult, the authorisation of legal guardianship issued by either the Civil Guard or the National Police along with the National ID Cards of both the minor and accompanying adult. In the case of foreigners, the equivalents of these documents in their countries of origin must be presented.

In additions to the previously stated, the parent or legal guardian of the minor will be required to sign a document assuming all responsibility, direct or indirect, for the entrance of the minor to the event. In the case that a parent or legal guardian refuses to

sign this document, the Organization reserves the right to deny entry of the minor to the concert venue.

The failure of a parent or legal guardian to comply with the obligations relating to the responsible protection and custodianship of a minor will authorise the Organisation to expel said adult and the accompanying minor from the venue.

The failure to comply with the previously mentioned requisites will not give the individual in question the right to a refund for the price paid for ticket.

8.- Attendees may be searched in accordance with current legislation; entering the venue with objects considered dangerous by the Organisation or prohibited by law is forbidden (to name a few: fireworks, arms, bottles glass objects, laser pointers, etc.).

9.- All image and intellectual-property rights derived, directly or indirectly, from the artistic performances or any other activities taking place as part of the celebration of the event are reserved.

10.- People attending the event expressly and unequivocally consent to and authorise that their images and voices might be captured by media channels during the celebration of said event, and may later be broadcast by the Organisation or authorised third parties in any media channel deemed appropriate for the promotional and/or commercial purposes of the event.

12. EVENT ACTIVITIES

Every activity occurring in the event may has its own terms and conditions available on www.superheroes.infinityconventions.com and shall be known by the attendees.
